





MEMORANDUM OF AGREEMENT

STREET DANCE FESTIVAL CHOREOGRAPHY SERVICES FOR THE MUNICIPALITY OF BULALACAO'S PARTICIPATION TO THE ORIENTAL MINDORO FESTIVAL SHOWCASE 2025 IN LINE WITH ORIENTAL MINDORO 75TH FOUNDING ANNIVERSARY CELEBRATION

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and executed into this 06th day of November, 2025 in Roxas, Oriental Mindoro and between.

Mr. JOHN KARL AMIGABLE ABELLANA, of legal age, single, an established Festival Choreographer, and a resident of Barangay San Roque 2 of the Municipality of San Jose, Occidental Mindoro;

- and -

The **LOCAL GOVERNMENT UNIT OF BULALACAO**, a government entity duly organized and existing under the laws of the Republic of the Philippines with principal office at Municipal Building, Brgy. Poblacion, Bulalacao, Oriental Mindoro represented in this Act by its Mayor, **HON. LUMELITO M. CABAGAY**.

Witnesseth: That

WHEREAS, the Provincial Government of Oriental Mindoro annually organizes events and activities in line with the Celebration of the Province's Founding Anniversary, and one of the confirmed events is **The Oriental Mindoro Festival Showcase 2025**;

WHEREAS, the Local Government Unit of Bulalacao submitted confirmation of the Municipality's participation to **The Oriental Mindoro Festival Showcase 2025**;

WHEREAS, Bulalacao Municipal Tourism Office initiated to request for proposals from known Street Dance Festival Choreographers, and the proposals include conceptualization of the whole presentation, conceptualization for costume and props, and the quotation for professional fee.

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual covenants herein contained, the **PARTIES**, do hereby bind themselves and agree to the following:

ARTICLE I THE PROJECT

Hiring Mr. John Karl Amigable Abellana for the preparation of the Official Contingent of the Municipality of Bulalacao to **The Oriental Mindoro Festival Showcase 2025** based on the proposal submitted to Bulalacao Municipal Tourism Office

ARTICLE II RESPONSIBILITIES OF THE PARTIES

I. **MR. JOHN KARL AMIGABLE ABELLANA**

- Maintain full and exclusive commitment to the Local Government Unit of Bulalacao from the execution of this Memorandum of Agreement until the conclusion of The Oriental Mindoro Festival Showcase 2025, and shall not engage in any other professional commitments or projects that may conflict with or hinder the performance of the obligations herein;
- Constitute a creative team composed of, but not limited to, choreographer, assistant choreographers, visual artist, and musician;
- Take full responsibility for the development, design, and execution of the overall

- Undertake regular and consistent coordination with the Bulalacao Municipal Tourism Office and Bulalacao National High School relative to the planning, implementation, and progress of the project.;
- Supervise, manage, and ensure the proper handling of approximately one hundred sixty (160) participants from the commencement of rehearsals until the contest proper;
- Prepare and develop a presentation routine and choreography with a total duration of approximately seven (7) minutes for the in-place presentation and three (3) minutes for the street dance presentation;
- Handle obligations during practices;
- Assist and collaborate in the execution and realization of the approved concepts for props and costumes as set forth in the project proposal;

II. THE LOCAL GOVERNMENT UNIT OF BULALACAO


- Prepare and pay Mr. John Karl Amigable Abellana of his talent fee in the amount of two hundred thousand pesos (PhP 200,000.00), the lowest quotation received by Bulalacao Municipal Tourism Office for amazing concepts and ideas presented and which shall be payable in two (2) tranches, subject to the usual government accounting and auditing rules and regulations, as follows:
 - First Payment: Fifty percent (50%) of the total amount shall be released upon commencement of rehearsals and upon submission of an initial accomplishment report;
 - Final Payment: The remaining fifty percent (50%) shall be released upon the successful completion of The Oriental Mindoro Festival Showcase 2025 and submission of the final accomplishment report duly accepted and approved by the LGU of Bulalacao.
- Provide logistical, financial, and administrative support necessary for the conduct of rehearsals, production preparations, and participation in the Festival Showcase;
- Supervise development of the preparation and provide input(s), as necessary;
- Regularly check for the needs in the preparation, and the safety of all concerned

ARTICLE III EFFECTIVITY

The Memorandum of Agreement shall take effect immediately and shall remain in effect unless otherwise terminated or upon the satisfaction of the objectives for which this Agreement has been forged.
