MEMORANDUM OF AGREEMENT (MOA)

KNOW ALL MEN BY THESE PRESENTS:

This **MEMORANDUM OF AGREEMENT** made and entered into this _____ day of _____ 2025 at Calapan City, Oriental Mindoro by and between:

ORIENTAL MINDORO ELECTRIC COOPERATIVE, INC. (ORMECO),
a non-stock non-profit electric distribution utility organized and existing pursuant to Presidential Decree No. 269, as amended, with principal address at Simaron, Sta. Isabel, Calapan City, Oriental Mindoro, duly represented herein by **HUMPHREY A. DOLOR, PECE, MBA**, in his capacity as the **General Manager**, hereinafter referred to as **ORMECO, Inc.;**

- AND -

THE MUNICIPAL GOVERNMENT OF BONGABONG, a local government unit organized and existing in accordance with the laws of the Republic of the Philippines, with principal address at Barangay Poblacion, Municipality of Bongabong, Province of Oriental Mindoro, duly represented herein by **HON. JOHN MICHAEL K. MALALUAN**, in his capacity as the **Municipal Mayor**, hereinafter referred to as **LGU BONGABONG;**

(Sometimes jointly referred to as the "PARTIES")

WITNESSETH:

WHEREAS, the **ORMECO, Inc.** is the local electric distribution utility authorized to sell, distribute electric power and extend line services throughout its entire franchised area;

WHEREAS, the **Local Government Unit of Bongabong (LGU Bongabong)** is implementing the project entitled *Concreting of Sitio Centro to Sitio Balete, Hagar Farm-to-Market Road (Identified as PRDP SU-1B-RO4B-ORM-001-BON-001-2022 FMR)* under the Philippine Rural Development Project (PRDP), which affects several existing electric poles that need to be adjusted to the new road right-of-way;

WHEREAS, following the conduct of surveying works by **ORMECO, Inc.,** it was determined that **LGU Bongabong** is required to enter into a contract with **ORMECO, Inc.,** which shall be effective upon signing, for the implementation of the said project;

WHEREAS, **LGU Bongabong** recognizes that **ORMECO, Inc.** has no immediate budget allocation for such request being not included in its annual work plan electrification projects, is willing to shoulder the full cost of the said electric distribution line extension project for its immediate implementation and by arranged contribution in aid of construction by the consumer.

NOW THEREFORE, for and in considerations of mutual covenant and agreement hereinafter set forth, the parties have mutually agreed as follows:

ORMECO, Inc. SHALL:

1. Undertake the necessary surveying activities for the proposed electric distribution line construction project.
2. Provide **LGU BONGABONG** the appropriate and approved design/plan for its official reference in the implementation of the proposed project.
3. Provide **LGU BONGABONG** the appropriate and approved costing of the proposed project.
4. During the execution of construction, assume full responsibility over its scope of works with regard to sound engineering practice and standard electrical requirements.
5. Conduct the final inspection of the completed electric distribution line construction project. Upon full compliance and without any arising difficulties, line energization will then be scheduled as requested by the **LGU BONGABONG**.
6. Exercise reasonable diligence to provide constant and uninterrupted supply of electric power. However, the **ORMECO, Inc.** shall not be liable for any power interruption or defects arising from the act of God, lawful order from government authority, power shortage on the part power generating entity; NPC, IPP; repairs, renovations, actions of the element, public enemy, labor trouble, or/and any similar events beyond the reasonable control of the **ORMECO, Inc.** Whenever possible, the **ORMECO, Inc.** shall give sufficient written notice to the **LGU BONGABONG**.

LGU BONGABONG SHALL:

1. Settle the specified amount to the **ORMECO, Inc.** indicated in the cost estimate issued by **ORMECO, Inc.**, upon completion of the project.
2. Grant free access to any duly authorized representative of the **ORMECO, Inc.** for the purpose of inspecting and other activities related to the function or transaction of **ORMECO, Inc.** The presence of **LGU BONGABONG** representatives is essential during these activities of the **ORMECO, Inc.** in inspection of the completion of the project.
3. In case of a project relating to pole construction, change or transfer, allow potential consumer/s within the said site to freely connect to this constructed electric distribution line section as directed by the **ORMECO, Inc.**
4. Recognize that the cost of investment for the construction of this electric distribution line section shall be treated as contribution in aid of construction hence its full authority and rights belongs to the **ORMECO, Inc.**
5. In case of construction or relocation of poles, responsible for securing all right of way grants before the final approval of electric distribution line design.
6. Fully conform to rules and regulations set by the **ORMECO, Inc.**
