AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE ERNILO C. VILLAS TO NEGOTIATE WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) THE EXTENSION OF AVAILMENT PERIOD OF THE LGU'S APPROVED TERM LOAN FROM JUNE 30, 2025 TO JUNE 30, 2026 AND TO SIGN ANY AND ALL DOCUMENTS RELATIVE TO THE EXTENSION OF AVAILMENT PERIOD

WHEREAS, the Municipality of Bulalacao, Oriental Mindoro has an approved Omnibus Term Loan Agreement with the Development Bank of the Philippines (DBP) Calapan (Mindoro) Lending Center for the purpose of financing the various priority and developmental projects of the Municipality;

WHEREAS, the availability period of the said loan was extended until June 30, 2025;

WHEREAS, being the LGU Bulalacao's partner in the financed projects, the Development Bank of the Philippines is being requested to grant an extension of the availment period from June 30, 2025 to June 30, 2026.

BE IT, THEREFORE RESOLVED, To: Authorize the Municipal Mayor, Honorable Ernilo C. Villas to negotiate with the Development Bank of the Philippines (DBP) and to sign all documents relative to the request for the extension of availment period from June 30, 2025 to June 30, 2026 of the LGU Bulalacao's approved Omnibus Term Loan Facility subject to payment of extension fee.

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

Section 1. Title. This ordinance will be called "An ordinance authorizing the Local Chief Executive, Honorable Ernilo C. Villas to negotiate with the Development Bank of the Philippines (DBP) the extension of availment period of the LGU's approved Omnibus Term Loan from June 30, 2025 to June 30, 2026 and to sign any and all documents relative to the extension of availment period".


Section 2. Basis. Pursuant to R.A. 7160, Sec. 22 © Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous places in the municipal hall.


Section 3. Separability Clause. Any provision hereof which may be declared unconstitutional by a competent court shall not affect the rest of the provisions hereof not otherwise so declared.


Section 4. Repealing Clause. All ordinances, rules and regulations or parts hereof, in conflict or inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 5. Effectivity. This Ordinance shall take effect upon approval.






