AN ORDINANCE GRANTING HONORARIUM EQUIVALENT TO SALARY GRADE 10 FOR HEAD OF THE OFFICE OF SENIOR CITIZENS AFFAIR (OSCA) IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN ACCORDANCE WITH REPUBLIC ACT NO. 9994 OTHERWISE KNOWN AS EXPANDED SENOR CITIZENS ACT OF 2010

WHEREAS, Article III, Section 447, Paragraph (5) (XVII) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that the Municipality shall approve ordinance which shall ensure the efficient and effective delivery of basic services and facilities and in addition shall formulate policies and adopt measure mutually beneficial to the elderly and to the community, provide incentives for non-government agencies and entities subject to the availability of funds, appropriate funds to support programs and projects for the benefit of Senior Citizens;

WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro has existing ordinances which empowers and protects the rights of the senior citizens of this municipality under Municipal Ordinance No. 20-10-277 and Municipal Ordinance No. 21-01-282;

WHEREAS, it is ideal and orderly to adopt a national law that will directly deliver services and programs for the senior citizens, and put it into a municipal enactment that shall guarantee all the benefits, enjoyment and active participation of senior citizens in the municipality;

WHEREAS, under Republic Act No. 9994 otherwise known as Expanded Senior Citizens Act of 2010, the local government is authorized to provide honorarium equivalent to Salary Grade 10;

NOW, THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:


Section 1. The Local Government Unit of Bulalacao, Oriental Mindoro hereby adopts Republic Act No. 9994 otherwise known as Expanded Senior Citizens Act of 2010.

Section 2. In view of the adoption, the Local Government Unit of Bulalacao, Oriental Mindoro is allowed to provide honorarium equivalent to a maximum of Salary Grade 10 to the Head of the OSCA upon availability of funds.

Section 3. The following are the functions of the OSCA as prescribed by this ordinance:

- a. To plan, implement and monitor yearly work programs in pursuance of the objectives of Republic Act No. 7432 or the Senior Citizens Act.
- b. To draw up a list of available and required services which can be provided by the senior citizens.
- c. To maintain and regularly update on a quarterly basis the list of senior citizens and to issue nationally uniform individual identification cards which shall be valid anywhere in the country.
- d. To serve as a general information and liaison center to serve the needs of the senior citizens.

Section 4. Effectivity. This Ordinance shall take effect upon its approval.
