RESOLVED, to approve the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 2
SUPPLEMENTAL BUDGET NO. 2
FOR CALENDAR YEAR 1983

APPROPRIATING THE AMOUNT OF ₱4,049,171 FOR OPERATING EXPENSES OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

SECTION 1. This Ordinance shall be known as Appropriation Ordinance No. 2 of the Municipality of Bulalacao, Oriental Mindoro for CY 1983;

SECTION 2. The source of fund wherein the expenses is herein appropriated shall be taken from the General Fund in the amount of ₱70,987.85 and from the Infrastructure Fund in the amount of ₱ 23,061.86 for operating expenses of the Municipality;

SECTION 3. All expenses chargeable against the Appropriation herein mentioned shall be made upon properly executed Voucher, payroll duly approved by the Municipal Mayor and the Municipal Treasurer in accordance with existing rules, laws, and regulations;

SECTION 4. This Ordinance shall take effect immediately after its passage;

RESOLVED, FURTHER, that copies of this Ordinance be furnished the Provincial Treasurer, Calapan, Oriental Mindoro for review and approval.
