RESOLVED, to approve the following Ordinance;

ORDINANCE NO. 4 ✓

ORDINANCE

REQUIRING SENTINCIADOR, SULTADOR AND GAFFERS IN THE COCKPIT AREAN OF BULALACAO, ORIENTAL MINDORO TO PAY TO THE MUNICIPAL TREASURER THE AMOUNT OF P10.00 FOR EVERY PERMIT ISSUED BY THE MUNICIPAL MAYOR AND SHALL PROVIDE FINES AND PUNISHMENT FOR VIOLATION HEREOF

WHEREAS, the town of Bulalacao has one cockpit arena, situated at Sitio Odiong, this Municipality;

WHEREAS, there are Sentinciador, Sultador and gaffer in this Cockpit arena;

WHEREAS, these Sentinciador, Sultador and gaffer need to secure Mayor's Permit before performing their respective duties;

WHEREAS, in order to regulate the rate of Mayor's Permit of Sentinciador, Sultador and gaffer in this Municipality, the Sangguniang Bayan, hereby Ordains, that:

SECTION 1.- Sentinciador, Sultador and Gaffer in the Cockpit Arena of Bulalacao, Oriental Mindoro are hereby required to pay Mayor's Permit fee in the amount of P10.00 before performing their respective duties;

SECTION 2.- Violation of this Ordinance or parts hereof, shall be fined the amount of ₱25.00 to ₱200.00 or an imprisonment of 10 to 30 days or both such fine and imprisonment at the discretion of the Court;

SECTION 3.- Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 4. This Ordinance shall take effect immediately after its approval.

UNANIMOUSLY APPROVED.
