FOR CALENDAR YEAR 1985

AN ORDINANCE APPROVING THE BUDGET OF THE LOCAL SCHOOL BOARD IN THE AMOUNT OF TEN THOUSAND EIGHT HUNDRED EIGHTY (P10,880.86) PESOS AND EIGHTY SIX CEN-
TAVOS

SECTION 1. This Ordinance shall be known as the Budget of the Local School Board of the municipality of Bulalacao, Oriental Mindoro for CY 1985;



SECTION 4. This Ordinance shall take effect immediately;


