FOR CALENDAR YEAR 1985


APPROPRIATING THE SUM OF SIX THOUSAND ₱6,000.00 PESOS TO BE TAKEN FROM ANY AVAILABLE FUND OR FROM ANY FUND ALREADY APPROPRIATED BUT NEVERTHELESS NOT YET UTILIZE FOR THE PURPOSE FOR FOOD/MEAL EXPENSES OF THE CAGAYAN VALLEY SANITARIUM AND HOSPITAL OUTREACH TEAM WHICH UNDERGO MEDICAL SERVICES BEGINNING FEBRUARY 1 TO 8, 1985 IN THIS MUNICIPALITY

SECTION 1. There is hereby appropriated the sum of SIX THOUSAND (₱6,000.00) PESOS To be taken from any available fund or from any fund already appropriated but nevertheless not yet utilize for the purpose for food/meal expenses of the Cagayan Valley Sanitarium and Hospital Outreach Team who will undergo medical mission in this municipality beginning February 1-8, 1985;

SECTION 2. This Appropriation Ordinance shall take effect immediately;
