RESOLUTION REQUESTING THE OIC PROVINCIAL GOVERNOR TO INCLUDE IN THE INFRASTRUCTURE PROGRAM FOR CALENDAR YEAR 1987, THE CEMENTING OF CALAPAN SOUTH JUNCTION-BULALACAO ROAD

WHEREAS, Calapan South Junction-Bulalacao Road with the total length of 2.20 kilometers was included in the list of Provincial Roads filed in the office of the Provincial Engineer;

WHEREAS, the undergoing Infrastructure Program of the Provincial Government of Oriental Mindoro prioritized the cementing of Provincial Roads as could be seen in the completion of cemented Calapan South Junction-Naujan Beach Road and the nearing completion cemented Calapan South Junction-Roxas Beach Road;

WHEREAS, this Body believed that it is but proper that the next target for cementing of Provincial Road will be the Calapan South Junction-Bulalacao Road being the shortest in terms of length and will greatly benefit the majority of our people especially the teachers and students coming from Poblacion and adjacent Barangays who are teaching and studying, respectively, in Bulalacao Municipal High School, situated at two (2) kilometers distance from Poblacion and along this road;

NOW, THEREFORE, resolved as it is hereby resolved to request the OIC Provincial Governor to include in the Infrastructure Program of the Provincial Government of Oriental Mindoro for Calendar Year 1987 the cementing of Calapan South Junction-Bulalacao Road;

RESOLVED, FURTHER, that copies of this Resolution be furnished the OIC Provincial Governor; the Provincial Engineer and the Sangguniang Panlalawigan, Chairman, Committee on Infrastructure, all of Calapan, Oriental Mindoro, for their consideration and proper action.
