tion fees paid by the students;

WHEREAS, tuition fees of students of Bulalacao Municipal High School is
not enough for the salaries of teachers and other expenditures;

WHEREAS, the Municipal government of Bulalacao has a meager income hence
cannot ran alone this Municipal High School;

NOW, THEREFORE, resolved as it is hereby resolved that the Sangguniang
Bayan of Bulalacao in session hereby agreed to request Her Excellency Presi-
dent Corazon C. Aquino, Malacanang Manila, for the Nationalization of the Bula-
