WHEREAS, inadequate potable water supply, is the perennial problem of the inhabitants of this municipality;

WHEREAS, we are informed that the national government is giving financial, technical and material assistance to the depressed communities such as Bulalacao, especially in providing adequate supply of water considered one of our basic needs;

WHEREAS, MLC-BWP/USAID have proposed 4 million waterworks project in this town but has not been implemented;

WHEREAS, if this project will be push-through, the residents of Barangays, Poblacion, Campaasan and Tabok will be fully benefited;

NOW, THEREFORE, resolved, as it is hereby resolved, to request the Honorable Deputy Minister, Ministry of Local Government, Quezon City, to expedite the construction of Bulalacao Waterworks Project, for the benefit of the majority of the people of Bulalacao;
