EARNESTLY REQUESTING THE HONORABLE HILARION RAMIRO, SECRETARY, DEPARTMENT OF HEALTH, TO PROVIDE AN AUGMENTATION FUND FOR THE COMPLETION OF BULALACAO MUNICIPAL HOSPITAL IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Congress enacted Republic Act No. 6910, also known as ' An Act Establishing a Ten-Bed Municipal Hospital in the Municipality of Bulalacao, Oriental Mindoro to be known as the Bulalacao Municipal Hospital, and Appropriating Funds Therefor ', on March 9, 1992;

"WHEREAS, ^{Bulalacao} is a depressed town bereft of any medical clinics more so of a hospital to provide indispensable medical services especially during the hours of emergency where absence of available physician and medical equipments spell the difference between life and death;

"WHEREAS, the euphoria felt by the residents over the start of the construction of the said Hospital was suddenly wiped away and instead replaced by a gloomy sense of foreboding upon noticing that the construction was abruptly halted by 1992;

"WHEREAS, there is a present move from the Provincial Government to continue the delayed completion of mentioned Hospital to make the provision of essential and basic medical services a reality to the people of this Pro-Poor Municipality of Bulalacao, Oriental Mindoro;

"WHEREAS, such completion needs an additional budget considering the remaining amount of fund for the purpose, Now therefore, be it;


RESOLVED, AS IT IS HEREBY RESOLVED, To earnestly request the Honorable Hilarion Ramiro, Secretary, Depart-
