" RESOLUTION NO. 95-09-059

REFERRING TO THE COMMISSION ON AUDIT FOR INVESTIGATION AND PROPER ACTION THE ISSUANCE MADE BY FORMER MUNICIPAL TREASURER, MR WILFREDO V. DE LEON, OF A TEMPORARY RECEIPT

"WHEREAS, the officers of Tabok Fishing Village and Home-owners Cooperatives lodged several complaints before this Body, of the issuance unto them by former Municipal Treasurer Wilfredo V. de Leon by a Temporary Receipt on March 3, 1995 for their partial payment for exclusive fishery rights, Zone IV of Municipal Waters, in the amount of Forty Seven Thousand Five Hundred Eighty-Seven Pesos (P47,587.00);

"WHEREAS, apparently, said money was not remitted to the municipal treasury as alleged by Mr. Nachor S. Cabagay, In-Charge of Office, MTO, during the regular session of this Sanggunian on July 24, 1995;

"WHEREAS, this august Body did not fail to advise and forewarn Mr. de Leon of these informations and the possible actions that might be taken against him, that on July 25, 1995 through an official communication addressed to him, it particularly brought to his attention the provision of Article 213 par (b) of the Revised Penal Code where ' failure to issue a receipt, as provided by law, for any money collected officially by any public officer ' constitutes illegal exaction; and Chapter V of the National Accounting and Auditing Manual which says ' No payment of any nature shall be received by a collecting officer without immediately issuing an official receipt thereof';


"WHEREAS, this Sanggunian on that letter, gave Mr. de Leon ten (10) days to answer and settle the issue, otherwise it would elevate the matter to the proper authorities;

"WHEREAS, such warning was ignored by Mr. de Leon as he fails to make a clear, definite and unequivocal answer within and until the lapse of the prescribed period; Now, therefore, be it:


RESOLVED, AS IT IS HEREBY RESOLVED, To refer to the Commission on Audit for investigation and proper action the issuance of Temporary Receipt by Former Municipal Treasurer Wilfredo V. de Leon for the amount of Forty Seven Thousand Five Hundred Eighty-Seven Pesos (P47,587.00) paid by Tabok Fishing Village and Homeowners Cooperatives in the exclusive fishery rights on Zone IV, Municipal Waters, Bulalacao, Oriental Mindoro;


