"RESOLUTION NO. 99-06-129

EARNESTLY REQUESTING THE HONORABLE JINGGOY ESTRADA, PRESIDENT, LEAGUE OF THE MUNICIPALITIES OF THE PHILIPPINES TO GRANT ONE UNIT OF AMBULANCE TO THE LIGA NG MGA BARANGAY OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 491 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that there shall be an organization of all barangays, to be known as the Liga ng mga Barangay, for the primary purpose of determining the representation of the liga in the sanggunian and for ventilating, articulating and crystallizing issues affecting barangay government administration and securing, through proper and legal means, solutions thereto;

"WHEREAS, it is believed that the organization of the Liga ng mga barangay would promote friendship and cooperation, enhance mutual assistance and coordination among the member barangays and its constituents especially during the occurrence of emergencies;


"WHEREAS, being the Pro-Poor Municipality pursuant to Executive Order No. 370, Bulalacao, Oriental Mindoro is still devoid of sufficient medical facilities such as that of an ambulance;


"WHEREAS, the availability of the ambulance for the use of the patients coming from the barangay would lessen the difficulties and the burden of the concerned families who shall have several things to attend to; Now, therefore, be it
