"RESOLUTION NO. 95-07-039

AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACT WITH TABOK FISHING VILLAGE HOMEOWNERS COOPERATIVE GRANTING THE LATTER THE EXCLUSIVE RIGHTS TO CATCH BANGUS FRY, LAPU-LAPU FRY OR KAWAG-KAWAG OR FRY OF ANY SPECIES OF FISH PROPAGATION WITHIN THE AREA OF MUNICIPAL WATER ZONE IV

"WHEREAS, it is a manifest provision of the various legislative acts of this municipality dealing with the grant of exclusive right to catch fry of any species that no contract shall be drawn granting such right to any person without first paying the agreed rental fees determined through public auction;

"WHEREAS, the Bulalacao Cooperative Council, aware of the provision of Republic Act Numbered 7160, otherwise known as the Local Government Code of 1991, giving the cooperatives composed of marginal fishermen the privilege to have preferential treatment regarding the grant of the exclusive right, petitioned this sanggunian to bestow unto them such right, offering specific amounts as rentals to each municipal water zone;

"WHEREAS, the sangguniang bayan, convinced of the possible direct benefits that might be reaped by the members of the cooperatives, yielded to the request of the Bulalacao Cooperative Council, thus SB Resolution No. 95-02-008 was passed;

"WHEREAS, as contained on the aforementioned Resolution, Zone IV of the municipal waters was awarded to Tabok Fishing Village Homeowners Cooperative for the price of Fifty Thousand Pesos (P50,000.00);

"WHEREAS, until to date, the municipal government refused to enter into contract with the abovementioned Cooperative as there was no Official Receipt shown to corroborate the Cooperative's allegation that they already paid the amount, except for a Temporary Receipt dated 3 March 1995 signed by former Municipal Treasurer Wilfredo V. de Leon acknowledging the fact that indeed he received the amount of P47,587.00 from Mr. Petrono Candelario, Chairman of Tabok Fishing Village Homeowners Cooperative;


"WHEREAS, this Sanggunian after a careful perusal of the complaint raised by the Cooperative and a meticulous consideration and evaluation of the issues, feels that a contract of limited duration should be awarded to the Cooperative while awaiting the response of Mr. Wilfredo V. de Leon and resolution of the problem regarding the money (P47,587.00) which upon verification was not entered into official records nor was remitted to the municipal fund; Now therefore, be it:


RESOLVED AS IT IS HEREBY RESOLVED, That: The Honorable Gemma G. Salas Municipal Mayor, any provision of municipal ordinances or resolution to the contrary notwithstanding, be authorized to enter into contract with Tabok Fishing Village and Homeowners Cooperative granting the latter the exclusive right to catch and buy bangus fry, lapu-lapu fry or kawag-kawag or any species of fry of fish propagation from July 28, 1995 to August 5, 1995 at municipal water, zone IV;


