"WHEREAS, Bulalacao, Oriental Mindoro is one of those municipalities which experiences hot and dry seasons;

"WHEREAS, potable water for human and animal consumption generally comes from springs and water for agriculture mainly derived from rainfall and small rivers and swamps;

"WHEREAS, this condition is further exacerbated by the on-set of El Nino phenomenon resulting to drought and more importantly insufficiency of potable water;


"WHEREAS, the only visible solution for us to explore is to get this most important natural resources from ground water through the drilling of wells; Now, therefore, be it






