" RESOLUTION NO. 95-02-008

GRANTING THE EXCLUSIVE FISHERY RIGHTS TO THE REGISTERED CO-OPERATIVES OF MARGINAL FISHERMEN OPERATING WITHIN THIS MUNICIPALITY

"WHEREAS, Section 149 of Republic Act Numbered 7160, otherwise known as the Local Government Code of 1991, grants powers to municipalities over their municipal waters, including the grant of exclusive authority for the privilege to gather, take or catch bangus fry, prawn fry, or kawag-kawag fry, or fry of other species of fish propagation;

"WHEREAS, this Sangguniang Bayan by virtue of Resolution No. 95-01-002 set the date of public bidding for the privilege to gather fry in the municipal waters, where all interested parties may participate, on February 15, 1995;

"WHEREAS, this Sangguniang Bayan, on February 1, 1995, received a Petition from different cooperatives signed by their respective chairmen asking that this body grant them the preferential right to such fishery privileges;

"WHEREAS, this Sangguniang Bayan cognizant of the welfare of the residents of coastal barangays and aware of the provision of RA7160 that duly registered organizations and cooperatives of marginal fishermen shall have the preferential right to such fishery privileges recognizes the validity of the said Petition; Now therefore:

RESOLVED, AS IT IS HEREBY RESOLVED, TO defer the holding of public bidding of exclusive fishery rights as set under Resolution No. 95-01-002, and instead grant the same to the registered cooperatives of marginal fishermen at the hereunder compromised prices:
