REQUESTING THE CHAIRPERSON, MUNICIPAL DEVELOPMENT COUNCIL TO CONVENE IN ORDER TO STUDY AND EVALUATE THE IMPLEMENTATION OF DEVELOPMENT PROJECTS PROGRAMMED FOR CALENDAR YEAR 1999

"WHEREAS, Article 182, Rule XXIII of the Rules and Regulations Implementing the Local Government Code of 1991 provides that every LGU shall have a comprehensive multisectoral development plan to be initiated by the Local Development Council concerned and approved by its sanggunian. For this purpose, the municipal development council, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

"WHEREAS, for the best interest of the constituents, the Municipal Development Council of Bulalacao, Oriental Mindoro has formulated the 20% Development Plan aside from the Medium Term Development Plan covering the period of one year listing therein priority projects most beneficial to its people;






RESOLVED FURTHER, To: Let copy of this resolution be furnished the Municipal Planning and Development Coordinator for her information and consideration;


