REQUESTING THE DIVISION SCHOOLS SUPERINTENDENT, DR. BENJAMIN C. CRUZ TO ALLOCATE ONE MOUNTABLE SCHOOL BUILDING FOR SITIO STA. ROSA, BARANGAY SAN JUAN, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, education is essential to nation building as acknowledged by Section 17, Article II in the Declaration of State Policies of the 1987 Constitution; and further, it is mandated that basic education be made accessible to all Filipinos;

"WHEREAS, it is perplexing and disturbing, however, that we are long way from spreading the benefits of basic education to the great majority of our countrymen, especially those in far-off rural areas as reported by the Congressional Commission on Education (EDCOM) in 1991;

"WHEREAS, as an example, many children who are of school age at Sitio Sta. Rosa, Barangay San Juan, Municipality of Bulalacao, have to walk several kilometers in order to get elementary education;

"WHEREAS, the provision of one mountable school building in Sitio Sta. Rosa shall redound to the socio-economic benefits of the residents therein; Now, therefore, be it

RESOLVED AS IT IS RESOLVED", To : Request the Division Schools Superintendent, Dr. Benjamin C. Cruz to allocate one mountable school building for Sitio Sta.


