RESOLUTION NO. 01-08-100

REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, PROVINCIAL GOVERNOR THRU HONORABLE THADDEOUS VENTURANZA, VICE-GOVERNOR AND PRESIDING OFFICER, ORIENTAL MINDORO TO AFFIRM TERRITORIAL RIGHTS, JURISDICTION AND CONTROL OVER THE ISLAND OF LIWAGAO, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, it is by historical rights and proper legal supplementary evidences that the Municipality of Bulalacao, Province of Oriental Mindoro maintains that indeed the long contested Island of Liwagao legally belongs to this Municipality and to this Province in general;

"WHEREAS, the claim of the Province of Antique that such island had already been seeded to the Municipality of Caluya, Antique is totally baseless and the occupation is illegal for lack of Congressional Act nor Executive fiat, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To Request the Honorable Bartolome L. Marasigan, Provincial Governor thru Honorable Thaddeous Venturanza, Vice-Governor and Presiding Officer, Oriental Mindoro to affirm territorial rights, jurisdiction and control over the Island of Liwagao, Municipality of Bulalacao, Oriental Mindoro;
