EARNESTLY REQUESTING THE HONORABLE GEMMA G. SALAS, MUNICIPAL MAYOR TO EXPEDITE THE IMMEDIATE RELEASE AND FULL PAYMENT OF THE TERMINAL LEAVE BENEFITS OF THE FOUR (4) OUT-GOING MUNICIPAL OFFICIALS CHARGEABLE AGAINST THE FUND APPROPRIATED FOR SOCIAL SECURITY BENEFITS AND CLAIMS UNDER THE OFFICE OF THE SANGGUNIANG BAYAN

'WHEREAS, Section 523 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that an official or employee of the National Government or Local government unit separated from the service shall receive benefits such as that of a terminal leave benefits based upon on the monetary value of his earned leave credits;

'WHEREAS, there are three (3) Sangguniang Bayan Members and the Presiding Officer who will be separated from the service effective July 1, 2001 due to their failure to win in the recently conducted local election last May 14;


'WHEREAS, the Municipal Government has appropriated the amount of Two Hundred Thousand Pesos (P200,000.00), CY-2001 for Social Security Benefits and Claims of the out-going municipal officials who did not make it in the May 14, 2001 election;


'WHEREAS, the total amount for the terminal leave benefits of four out-going municipal officials is summed up to One Hundred Ninety Two Thousands Eight Hundred Ninety Eight Pesos and Thirty Eight Centavos (P192,898.38) which means that an enough fund is appropriated for the purpose; Now, therefore, be it
