REQUESTING FISCAL CEZAR ENRIQUEZ, OFFICE OF THE PROVINCIAL PROSECUTOR, PINAMALAYAN, ORIENTAL MINDORO TO DESIGNATE ASSISTANT PROVINCIAL FISCAL MANUEL DELOS REYES TO REPRESENT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO ON THE CASE INVOLVING LAND DISPUTE OWNED BY THE MUNICIPALITY AT BARANGAY CAMBUNANG

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is now engaged in a court litigation against a private person over a parcel of land which the former legally acquired from a certain Zacarias Castillo by virtue of Deed of Sale;

"WHEREAS, there arise a problem when the number of Lot bought by the Municipality, falls under the name of certain Elpidio Abrew; nevertheless the technical description of the land in dispute points out definitely to that property sold by Mr. Castillo in favor of the Municipality;


"WHEREAS, our present law provides that all instrumentalities or agencies of the State in times of legal dispute should be represented by a government counsel; hence, since there is an absence of both municipal and provincial legal officer, this Municipality is constrained to seek the legal assistance of the Office of the Provincial Prosecutor; Now, therefore, be it


