EARNESTLY REQUESTING THE HONORABLE RAMON MAGSAYSAY JR., SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) TO BE USED FOR THE REPAIR AND REHABILITATION OF THE WATER SYSTEM AT BARANGAY SAN ISIDRO, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is made known to this Body that the priority project of Senator Ramon Magsaysay Jr. includes the repair and rehabilitation of the water system;

"WHEREAS, Barangay San Isidro, Bulalacao, Oriental Mindoro is presently experiencing the difficulties and scarcity of potable water due to the defective pipelines;

"WHEREAS, the residents are long time requesting for the change of PVC pipes into a G.I. pipes to become more resistant to water pressure;

"WHEREAS, the distance from the source to the barangay is approximately 2 kilometers that the municipal government needs financial assistance from the benevolent senator to realize the project; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Ramon Magsaysay Jr., Senator, Republic of the Philippines to allocate the amount of One Hundred Fifty Thousand Pesos (P150,000.00) to be used for the repair and rehabilitation of the water system at Barangay San Isidro, Municipality of Bulalacao, Province of Oriental Mindoro;
