" RESOLUTION NO. 01-01-003

RESOLUTION STRONGLY OPPOSING THE USE OF THE ISLAND OF SEMIRARA ANTIQUE AS GARBAGE DUMPSITE OF METRO MANILA DEVELOPMENT AUTHORITY (MMDA)

"WHEREAS, Semirara Island was once a territory of the Municipality of Bulalacao, Province of Oriental Mindoro;

"WHEREAS, the stockpiling of different kinds of waste coming from Metro Manila to be dumped in the Island of Semirara would be inimical not only to health but also to the economy;

"WHEREAS, it should be known that Semirara is an island that has proximity to fishing grounds and therefore must be protected from any environmental harm that could dissipate the only labor known from the inhabitants which is fishing;

"WHEREAS, this ecological issue is brought out because of the fear that the seepage waste that might be produced by the garbage from Metro Manila would harm the production of fry of fish propagation and their habitat, ipso facto, our marginal fishermen would be affected;

"WHEREAS, the Island of Semirara is so proximate to the Island of Boracay, world-known tourism destination, which if the garbage waste from Metro Manila should be dumped at Semirara Island would affect the inflow of tourists thereby harming our national economy by denying us with so precious dollars;


