"WHEREAS, it is a constitutional mandate that the State shall assign the highest budgetary priority to education and that quality education be made available to all;

"WHEREAS, the school building at Maasin Elementary School are badly damaged and dilapidated to the inconvenience of both the teachers and pupils;
