Mindoro:

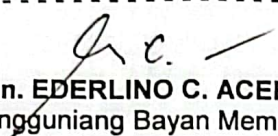
SECTION 1. A monthly honorarium of three thousand pesos

month.

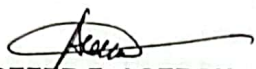
SECTION 2. Disbursement of funds is subject to the usual accounting
and auditing rules and regulations.

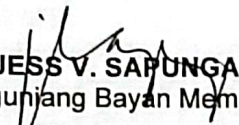
SECTION 3. This Ordinance shall take effect on January 2, 2025.

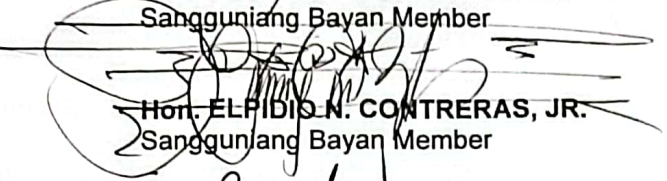

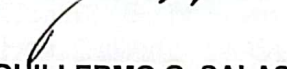

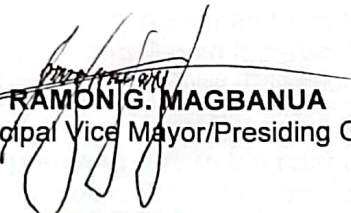
