**AN ORDINANCE ESTABLISHING BULALACAO TEEN HUB AND
PROVIDING A ROOM AT THE MUNICIPAL HEALTH OFFICE OF THE
MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
FOR THIS PURPOSE**

WHEREAS, Section 13, Article II of the 1987 Philippine Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being;

WHEREAS, Republic Act No. 8044 otherwise known as Youth in Nation-Building Act states that "Youth" is the critical period in a person's growth and development from the onset of adolescence towards the peak of mature, self-reliant and responsible adulthood comprising the considerable sector of the population from the age of fifteen (15) to thirty (30);

- b. Provide free adolescent and youth-friendly counselling services lead by the trained peer facilitators and/or designated officer from the MHO (AHD).
- c. Conduct community orientations in barangays in coordination with the government office or agency concerned regarding youth concerns, including but not limited to the following:

Youth Concerns	Government Agency
i. Lack of sex education and reproductive health awareness; and sexually transmitted infectious diseases, including HIV/AIDS	Municipal Health Office
ii. Teenage pregnancy	Municipal Health Office (AHD) and MSWDO
iii. Mental Health	Municipal Health Office
iv. Smoking and illegal drugs and substance use and abuse.	Municipal Police Station

- d. Conduct school-based orientations regarding the youth concerns mentioned above in coordination with the Bulalacao School District.
- e. Conduct seminars and workshops in coordination with the appropriate government office, agency and/or private or non-government institution to improve youth participation and promote youth development programs.
- f. Provide direct interventions toward the prevention of risky sexual and non-sexual behavior among teens.
- g. Provide opportunities for dialogue and interaction among teens.
- h. Provide counselling and life skills development opportunities for teens.
- i. Provide a venue where teens can hang out and play games, listen to music, watch movies, or simply talk with each other.

Section 5. Appropriation. The fund needed for the implementation of this Ordinance shall be included in the General Appropriation Fund Annual Budget of the Local Government Unit of Bulalacao, Oriental Mindoro under its Gender and Development (GAD) Fund. The amount for years after 2025 shall be based on the budget proposal to be submitted by Office of the Municipal Mayor. The Office of the Municipal Mayor through the Municipal Budget Officer shall ensure that the budget necessary for the implementation of this Ordinance is included in yearly appropriation. The fund allocated for this purpose shall not be allowed for realignment and not be certified as savings unless it served its purpose already within a particular fiscal year.

Section 6. Repealing Clause. Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.


