### AN ORDINANCE RECOGNIZING OUTSTANDING WOMEN IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

**WHEREAS**, Section 14, Article II of the 1987 Philippine Constitution provides that the State recognizes the role of women in nation building, and shall ensure the fundamental equality before the law of women and men;

**WHEREAS**, Section 2 of Republic Act No. 9710 also known as The Magna Carta of Women realizes that the State shall endeavor to develop plans, policies, programs, measures, and mechanisms to address discrimination and inequality in the economic, political, social, and cultural life of women and men;

**WHEREAS**, the Municipality of Bulalacao continuously progressing both economically and socially, it has a municipal government that establishes fundamental programs and services which empowers and recognizes the welfare and importance of women;

**WHEREAS**, the Local Government Unit of Bulalacao acknowledges and appraises exemplary women who are excelling in different distinguished field of specialization, like medicine, education, politics, arts, sports, business and others, and who are embodying a well-balanced character that are worthy of emulation;

**NOW, THEREFORE, BE IT ORDAINED**, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

**Section 1. Statement of Policy.** It is the policy of the Local Government Unit of Bulalacao to value the role and importance of women sector in the overall progress of the municipality, and provide special recognition to those who outstandingly perform in their distinguished field of specialization.

**Section 2. Title.** This Ordinance is entitled as stated and shall be also known as "2025 Outstanding Women Ordinance of Bulalacao".

**Section 3. Committee.** The Committee who shall be in charged in evaluating and confirming the Outstanding Women for a certain year in the Municipality of Bulalacao, Oriental Mindoro is hereby created:

Vice Chairperson	- MSWDO
Members	<ul style="list-style-type: none"><li>- Representative from Local Council for Women</li><li>- Sangguniang Bayan Member, Chairperson, Committee on Women, Children, Family Relations and Gender Equality</li><li>- Representative from Education/Academe Sector</li><li>- Representative from Medicine Sector</li><li>- Representative from Politics Sector</li><li>- Representative from Culture and Arts Sector</li><li>- Representative from Business and Entrepreneur Sector</li><li>- Representative from Associations and Cooperatives Sector</li><li>- Representative from Agriculture and Fishery Sector</li><li>- Representative from Indigenous People Sector</li></ul>

**Section 4. Functions of the Committee.** The Committee shall perform with utmost diligence the following functions:

- a. Prepare the nomination form.
- b. Formulate guidelines and criteria for the selection of nominations and winners.
- c. Assist the nominee in preparing the requirements.
- d. Declare the winners.

**Section 5. Nomination.** Any Bulalacaonon, group or association can nominate a female Bulalacaonon and submit their nomination to the Committee. The nomination must be in a formal writing, stating the character, trait, achievements, awards, recognitions and other accomplishments of the nominated female Bulalacaonon.

The Committee shall send a formal letter to the nominee signifying that they are one of the official nominees together with list of the requirements.

**Section 6. Awarding Ceremony.** The female Bulalacaonon who will be chosen as one of the Outstanding Women for a certain year shall be recognized and awarded in the celebration of National Women's Month. The awardees shall each receive Plaque of Recognition and other emoluments if applicable.

**Section 7. Implementation.** The Office of the Municipal Mayor shall ensure the implementation of this Ordinance annually.

**Section 8. Appropriation.** The fund needed for the implementation of this Ordinance shall be included in the General Appropriation Fund Annual Budget of the Local Government Unit of Bulalacao, Oriental Mindoro under its Gender and Development (GAD) Fund. The amount for years after 2025 shall be based on the budget proposal to be submitted by Office of the Municipal Mayor through the GAD Focal Person. The Office of the Municipal Mayor through the Municipal Budget Officer shall ensure that the budget necessary for the implementation of this Ordinance is included in yearly appropriation. The fund allocated for this purpose shall not be allowed for realignment and not be certified as savings unless it served its purpose already within a particular fiscal year.


**Section 9. Repealing Clause.** Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.


**Section 10. Separability Clause.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

**Section 11. Effectivity.** This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.

**ENACTED** this 24<sup>th</sup> day of March 2025 Bulalacao, Oriental Mindoro.






