ENTITLED "COMPREHENSIVE INVESTMENT INCENTIVES
ORDINANCE OF THE MUNICIPALITY OF BULALACAO, ORIENTAL
MINDORO" BY CHANGING AND DELETING CERTAIN PROVISIONS IN
VARIOUS SECTIONS THEREOF**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental
Mindoro:

SECTION 1. Certain sections of the Municipal Ordinance No. 17-05-
183 are hereby amended as follows:

- Amendment in the organizational structure of the Composition of
Board under Section 5 of Chapter III:

- a. Item D and E shall be changed both from President of the Bulalacao Business Club or its equivalent and President of the Bulalacao Retailers Association or its equivalent to President, Bulalacao Chamber of Commerce, or his duly authorized representative.
 - b. Inclusion of Local Economic Development and Investment Promotion Officer (LEDIPO) as one of the members.
 - c. Inclusion of Municipal Administrator as one of the members.
- ii. Amendment of Section 16 by changing the incentive period of 40 Million Pesos and above investment from five years to six years.
 - iii. Removal of item (1) *Exemption from local licenses, fees, and dues* under Section 17 of Chapter VII.
 - iv. Amendment of the set of percentages in the availment and reduction of business tax as stated in Section 17 (2) *Reduction of Business Tax* :

1 st	100%	100%	100%
2 nd	75%	100%	100%
3 rd	50%	75%	100%

- v. Inclusion of Non-Fiscal Incentives on Chapter VII and be determined as the new Section 18 of the Ordinance.

Non-Fiscal Incentives – a registered enterprise qualified to avail the tax incentives under this code shall be entitled to the following non-fiscal incentives to be provided by the Local Government Unit of Bulalacao through Bulalacao Investment and Incentive Board and other line agencies:

- a. Assistance in securing local permits and licenses.
 - b. Assistance in identifying business location and plant sites.
 - c. Joint venture match-making.
 - d. Facilitating service connections with local utilities.
 - e. Other non-fiscal incentives as may be determined by the Bulalacao Investment and Incentive Board.



- a. The Appropriation under Chapter VII shall be changed from Section 18 to Section 19.
- b. The Interpretation under Chapter VIII shall be changed from Section 19 to Section 20.
- c. The Tax Credits under Chapter VIII shall be changed from Section 20 to Section 21.
- d. The Judicial Relief under Chapter VIII shall be changed from Section 21 to Section 22.
- e. The Separability Clause under Chapter VIII shall be changed from Section 22 to Section 23.
- f. The Repealing Clause under Chapter VIII shall be changed from Section 23 to Section 24.
- g. The Effectivity under Chapter VIII shall be changed from Section 24 to Section 25.


SECTION 2. This amendment shall take effect immediately upon its approval.




