" RESOLUTION NO. 00-03-037-A

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2000 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF SEVEN HUNDRED SEVENTY FOUR THOUSAND EIGHT HUNDRED EIGHTY NINE PESOS (₱774,889.00) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2000-01, DATED JANUARY 6, 2000

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Poblacion, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2000 showing therein the sources of income and barangay expenditures starting from January 1, 2000 up to December 31, 2000;

"WHEREAS, the Barangay Fund Annual Budget for FY 2000 of Barangay Poblacion was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on March 6, 2000 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be reallocated to any other projects;


"WHEREAS, it is therefore understood that disbursements of appropriations shall be guided by existing COA rules and regulations; Now, therefore, be it


