**WHEREAS**, protecting the West Philippine Sea is crucial for the Philippines due to its rich marine biodiversity, vital fisheries and strategic importance for global trade and national security. The area is a significant source of food, livelihood for Filipino fishermen and a key route for international shipping. Its protection is also linked to the country's sovereignty and territorial integrity;

**WHEREAS**, the government has been asserting its sovereignty, rights and jurisdiction over the West Philippine Sea through various means, including diplomatic efforts, international arbitration and defense of our rights against encroachment;

WHEREAS, Republic Act 12064 (Philippine Maritime Zones) and Republic Act 12065 (Philippine Archipelagic Sea Lanes) determined the country's maritime zones and designated the archipelagic sea lanes and air routes;

**WHEREAS**, the government shall strengthen our defense capabilities and partnership with other countries to ensure national security and territorial integrity;

**WHEREAS**, it is imperative to enhance public awareness, consciousness and intergenerational appreciation of the Philippines national and maritime zones particularly in the West Philippine Sea;

**WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is cognizant about national efforts and struggles to maintain jurisdiction over the West Philippine Sea that this resolution is expressing strong and unwavering support to the National Government; **Now, therefore, be it**




