“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

“WHEREAS, Bulalacao, a 1st class municipality is a vast agricultural land, has 15 barangays and with a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector;

"WHEREAS, the Municipality has a tropical climate type conducive to planting of staple crops such as rice and corn including garlic, onions and varieties of vegetables and fruits transported to Manila and nearby provinces;


