AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 21-05-290 ENTITLED "AN ORDINANCE IDENTIFYING AND DECLARING CERTAIN TECHNICAL COURSES WHICH SHALL BE OFFERED BY THE BULALACAO TECHNICAL AND VOCATIONAL COLLEGE (BTVC) AND APPROPRIATING FUNDS THEREFOR" BY ADDING ITEMS IN SECTION 1 AND ADDING NEW SECTION THEREOF

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao
Oriental Mindoro:

SECTION 1. The Section 1 of the Municipal Ordinance No. 21-05 290 are hereby amended to read as follows:

i. The following technical courses shall be added under this section:

- a. Gas Metal Arc Welding (GMAW) NC I
- b. Manual Metal Arc Welding (MMAW) NC I
- c. Manual Metal Arc Welding (MMAW) NC II
- d. Dressmaking NC II
- e. Masonry NC I
- f. Masonry NC II
- g. Carpentry NC II
- h. Plumbing NC I
- i. Plumbing NC II

SECTION 2. This Ordinance shall have additional provisions as follows:

- a. The Bulalacao Technical Vocational College is also registered Assessment Center of SMAW NC I, SMAW NC II, GMAW NC II, and GTAW NC II.
- b. The funds for the implementation of programs may also be sourced from Trust Fund based on the recommendation of the BTVC administration.

SECTION 3. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.
