**MUNICIPAL ORDINANCE NO. 25-08-420**

**AN ORDINANCE AUTHORIZING THE COLLECTION OF  
MAINTENANCE FEE TO THE TRAINEES ENROLLED IN THE  
BULALACAO TECHNICAL VOCATIONAL COLLEGE**

**WHEREAS**, Article XIV, Section 1 of the Philippine Constitution provides that the State shall protect and promote the right of all citizens to quality education in all levels and shall take appropriate steps to make such education accessible to all;

**WHEREAS**, Section 129 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that "Each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees and charges subject to the provision herein, consistent with the basic policy of the local autonomy. Such taxes, fees and charges shall accrue exclusively to the local government units";

**WHEREAS**, Section 132 of the same law states that "The power to impose tax, fee or charge or to generate revenue under this Code shall be exercised by the Sanggunian of the local government unit concerned through an appropriate ordinance";

**WHEREAS**, the Bulalacao Technical Vocational College (BTVC) is an institution accredited by TESDA that offers Technical and Vocational Education and Training Programs (TVET) under the Technical Education and Skills Development Authority (TESDA) and the Commission on Higher Education (CHED), it is located at San Roque, Bulalacao, Oriental Mindoro;

**WHEREAS**, Bulalacao is a first-class municipality located at the southernmost tip of the Province of Oriental Mindoro, the present thrust of its Local Government for social services is to provide free, accessible and quality education for all;

**WHEREAS**, it is logical and advantageous to the local autonomy of this municipality to collect reasonable fees from the trainees enrolled in the Bulalacao Technical Vocational College;

**NOW, THEREFORE, BE IT ORDAINED**, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

**Section 1. Statement of Policy.** It is the policy of the Local Government Unit of Bulalacao to guarantee initiatives and ponder a systematic way of gaining local income to contribute in the progress of the municipality as a whole;

**Section 2. Title.** This Ordinance is entitled as stated and shall be also known as "2025 BTVC Maintenance Fee Ordinance".

**Section 3. Imposition of Fee.** The Bulalacao Technical Vocational College (BTVC) shall designate a cashier to collect the maintenance fee that will be remitted immediately to the Municipal Treasury Office for the issuance of receipt. The maintenance fee that will be collected from the enrolled trainees of the BTVC has a total amount of One Thousand Five Hundred Pesos (PhP1,500.00) for each which will be utilized as follows:

School ID and Uniforms	-	PhP500.00
Trainee Insurance	-	150.00
Personal Protective Equipment-		500.00
School Maintenance	-	350.00

**Section 4. Non-Scholar Trainees.** The BTVC shall collect a tuition fee from the non-scholar trainees which will be based on the Training Cost and Assessment Fees as indicated in the Approved Schedule of Costs of TESDA Scholarship Program.

**Section 5.** The collection of the maintenance fee from the enrolled trainees and tuition fee from the non-scholar trainees will be deposited to the Local Government Unit of Bulalacao, Oriental Mindoro Trust Fund Account and will be utilized based on usual accounting policies and procedures.

**Section 6. Repealing Clause.** Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

**Section 7. Separability Clause.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

**Section 8. Effectivity.** This amendment shall take effect immediately upon its approval.
