RULES, REGULATIONS AND PROCEDURES IN GRANTING  
FINANCIAL ASSISTANCE FOR INDIVIDUAL IN CRISIS SITUATION  
(AICS) IN BULALACAO, ORIENTAL MINDORO" BY INCREASING  
THE PETTY CASH FUND FROM PhP50,000.00 TO PhP150,000.00

"Section 5(e). The Municipal Treasury Office shall include in the cash advance of the Disbursing Officer the amount of one hundred fifty thousand pesos (PhP150,000.00) for the monthly petty cash fund exclusively for AICS. Such amount can be replenished immediately if at least seventy five percent (75%) of it is already disbursed".

Section 2. This ordinance shall take effect upon approval.
