MUNICIPAL ORDINANCE NO. 25-12-431

AN ORDINANCE ADOPTING THE REPUBLIC ACT NO. 10661 ALSO
KNOWN AS CHILDREN'S MONTH ACT FOR IMPLEMENTATION IN
THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao,
Oriental Mindoro, that:

WHEREAS, Republic Act No. 10661, also known as the "National
Children's Month Act," declares the month of November of every year as
"National Children's Month" to commemorate the adoption of the
Convention on the Rights of the Child by the United Nations General
Assembly on November 20, 1989;

WHEREAS, the State is mandated to defend the right of children to assistance and special protection from all forms of neglect, abuse, cruelty, exploitation, and discrimination;

WHEREAS, Section 4 of R.A. No. 10661 encourages all local government units to observe National Children's Month and participate in related activities;

WHEREAS, it is the policy of the Municipal Government of Bulalacao to prioritize the welfare and development of its children and integrate their rights and needs into local governance and development plans;

BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Bulalacao Children's Month Institutionalization Ordinance."

SECTION 2. PURPOSE. This Ordinance aims to:

- a. Formalize the annual observance of November as National Children's Month in the Municipality of Bulalacao;
- b. Create a structured, recurring program of activities that promotes children's rights and well-being;
- c. Ensure the allocation of dedicated annual funding for these activities and
- d. Designate the roles and responsibilities of local government offices and stakeholders in the implementation.

SECTION 3. INSTITUTIONALIZATION OF ACTIVITIES. The Municipality of Bulalacao shall observe National Children's Month annually in November. The municipal government, through the Local Council for the Protection of Children (LCPC) and the Municipal Social Welfare and Development Office (MSWDO), shall develop and implement a comprehensive program of activities focused on the welfare, development, and protection of children, aligned with the annual national theme set by the Council for the Welfare of Children (CWC).

SECTION 4. LEAD IMPLEMENTING AGENCIES AND ROLES

- a. Municipal Social Welfare and Development Office (MSWDO): Shall serve as the primary implementing arm, responsible for coordinating, planning, and executing the month's activities.
- b. Local Council for the Protection of Children (LCPC): Shall oversee the planning process, ensure broad participation of all relevant stakeholders (including children's representatives), and monitor the effectiveness of the programs.
- c. Municipal Planning and Development Office (MPDO) and Municipal Budget Office (MBO): Shall ensure the integration of the Children's Month budget into the annual municipal budget process.
- d. Department of Education (DepEd) Bulalacao District: Shall lead activities within public schools.
- e. Municipal Health Office (MHO): Shall focus on child health, nutrition, and wellness activities.

SECTION 5. FUNDING. The amount necessary for the initial implementation of this Ordinance shall be sourced from the existing LCPC Fund or other available funds of the municipality. Hereafter, an annual budget shall be incorporated into the General Appropriations Ordinance of the Municipality of Bulalacao, specifically allocated for the observance of National Children's Month. This fund shall be managed in accordance with existing government budgeting, accounting, and auditing rules and regulations.


SECTION 6. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and effective.

SECTION 7. REPEALING CLAUSE. All ordinances, resolutions, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed, modified, or amended accordingly.


SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.







[REPUBLIC ACT NO. 10661, May 29, 2015]

AN ACT DECLARING NOVEMBER OF EVERY YEAR AS NATIONAL CHILDREN'S MONTH

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. This Act shall be known as the "National Children's Month Act".

SEC. 2. The month of November of every year is hereby declared as "National Children's Month". This declaration commemorates the adoption of the Convention on the Rights of the Child by the United Nations General Assembly on 20 November 1989, and seeks to instill its significance in the Filipino consciousness.

SEC. 3. Pursuant to the observance of National Children's Month, an annual program of activities shall be prepared and implemented, with the Department of Social Welfare and Development (DSWD), the National Youth Commission (NYC), and the Council for the Welfare of Children (CWC) as lead agencies. They are authorized to call upon any department, bureau, office, agency, or instrumentality of the government, including government-owned or -controlled corporations, for any assistance as may be needed in the discharge of the tasks under this Act.

SEC. 4. The Department of Education (DepED) and the Commission on Higher Education (CHED) shall facilitate and encourage the commemoration of this month in all schools, public and private, nationwide.

The Philippine Information Agency, in coordination with the DSWD, the DepED, the CHED, the NYC and the CWC shall ensure the effective information dissemination of this Act.

All local government units and private organizations including the civil society, private enterprises, and nongovernment, civic, and people's organizations, are encouraged to observe National Children's Month in simple rites and participate in the activities.

SEC. 5. Proclamation No. 74 (s. 1992) and Proclamation No. 267 (s. 1993) are hereby repealed. Any other provision of law, decree, order, rule, or regulation inconsistent with this Act is hereby repealed or modified accordingly.

SEC. 6. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
