**WHEREAS**, the Registry System for Basic Sector in Agriculture (RSBSA) is a comprehensive database developed by the Department of Agriculture (DA) that complies essential information on farmers, farmworkers, fisherfolks, agri-youth and other primary stakeholders, including their socio-economic profiles and agricultural activities;

**WHEREAS**, the RSBSA serve as a basis for implementing government programs and interventions, including production inputs, financial assistance, insurance services, and other agricultural support programs as mandated by the General Appropriation Act (GAA);

**WHEREAS**, the Memorandum Order dated February 1, 2024 introduced the RSBSA Profiling Platform for Local Government Units (RSBSAPP-LGU) to facilitate the encoding of new registrations and updates to existing RSBSA records at the municipal level;

**WHEREAS**, in order to implement the RSBSA Profiling Platform for Local Government Units (RSBSAPP-LGU) for the benefit of the farmers and fisherfolks in Bulalacao, Oriental Mindoro, there is a need for the Local Chief Executive, Honorable Lumelito M. Cabagay to enter into a Data Processing and Non-Disclosure Agreement with the Department of Agriculture-Regional Field Office (DA-RFO);

**WHEREAS**, a copy of Data Processing and Non-Disclosure Agreement has been provided, which includes provisions on data confidentiality, dispute resolution and necessary amendments between the parties; **Now therefore, be it**
