WHEREAS, the conduct of public land survey by the DENR will facilitate the proper classification and delineation of such areas, paving the way for their conversion into alienable and disposable lands, thereby granting legitimate occupants the right to secure land titles and promote land tenure security;

WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro is hounded with financial constraints that seeking financial assistance from the DENR is its only hope; **Now, therefore, be it**
