RESOLUTION REQUESTING PAG-IBIG (HOME DEVELOPMENT MUTUAL FUND) TO GRANT AT LEAST A THREE (3) MONTHS MORATORIUM ON THE PAYMENT OF LOAN AMORTIZATION OF EMERGENCY/CALAMITY LOANS OF MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO
