"WHEREAS, it is the primary responsibility of the local government unit (LGU) to ensure the general welfare of its constituents, which includes the provision of essential services such as access to clean and reliable water sources for both domestic consumption and agricultural use;

"WHEREAS, the Municipality of Bulalacao, a third-class municipality in Oriental Mindoro, often faces challenges with water supply, particularly in its agricultural sector, due to variable rainfall and insufficient irrigation infrastructure, which affects farmers' productivity and livelihood;

"WHEREAS, the lack of readily available machinery, specifically a water well drilling rig, hampers the municipal government's efforts to develop new groundwater sources and establish deep wells in strategic locations to address the water scarcity issue;
