WHEREAS, Ugyong Katutubong Mangyan Integrated School (School ID 137016), located in Barangay Benli, Municipality of Bulalacao, Province of Oriental Mindoro, serves the educational needs of the local Mangyan Indigenous Cultural Community;

WHEREAS, the current school facilities are insufficient to accommodate the growing number of students and meet the required standard classroom-to-student ratio, thereby affecting the quality of education and the learning environment;
