DIRECT MARITIME TRANSPORT ROUTE BETWEEN THE PORTS OF THE
MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO,
AND MUNICIPALITIES OF CORON AND EL NIDO, BOTH IN THE
PROVINCE OF PALAWAN**

WHEREAS, the Municipality of Bulalacao, Oriental Mindoro, the Municipality of Coron, and the Municipality of El Nido, both in the Province of Palawan, possess significant potential for economic growth, trade, and tourism, which is currently inhibited by limited direct inter-island connectivity;

WHEREAS, existing maritime routes often require lengthy detours, increasing the cost and time of transport for goods and passengers, thereby burdening local residents and businesses;

WHEREAS, the establishment of a direct Roll-on/Roll-off (RoRo) or fast craft service between these ports is consistent with the national government's "Strong Republic Nautical Highway" program and the Maritime Industry Development Plan (MIDP) 2028, which aims to enhance connectivity and foster economic interaction among the archipelago's islands;
