RESOLUTION REQUESTING THE PHILIPPINE CROP INSURANCE CORPORATION (PCIC) TO ESTABLISH A SERVICE OFFICE OR DESIGNATE PERMANENT PERSONNEL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO, TO EXPEDITE THE VALIDATION AND PROCESSING OF AGRICULTURAL CROP CLAIMS

WHEREAS, the Philippine Crop Insurance Corporation (PCIC) is the government agency mandated to provide insurance protection to farmers against losses arising from natural disasters, plant diseases, and pest infestations;
