**RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS  
AND HIGHWAYS (DPWH) TO ALLOCATE FUNDS FOR THE  
CONSTRUCTION OF A GABION OR DIKE ALONG THE RIVER IN SITIO  
CAGURAY, BARANGAY BENLI, MUNICIPALITY OF BULALACAO,  
ORIENTAL MINDORO**

**"WHEREAS**, the Department of Public Works and Highways (DPWH) is the national government agency mandated to plan, design, construct, and maintain infrastructure projects, including flood control and river protection works;

**"WHEREAS**, Sitio Caguray, Barangay Benli, Municipality of Bulalacao, Oriental Mindoro is situated along a river that is highly susceptible to flooding and riverbank erosion, especially during periods of heavy rains and typhoons;

**"WHEREAS**, the continuous erosion of the riverbank poses a serious threat to the lives, properties, and livelihoods of the residents of Sitio Caguray, particularly the Hanunuo Mangyan families residing in the area;

**"WHEREAS**, a significant portion of the land affected by the erosion constitutes ancestral land traditionally owned and occupied by the Hanunuo Mangyan, and the ongoing loss of land threatens their cultural heritage, primary source of livelihood, and way of life;

"WHEREAS, the construction of a gabion or dike along the affected portion of the river is a viable and long-term solution to prevent further erosion, mitigate flooding, protect lives and properties, and preserve the ancestral lands of the Hanunuo Mangyan community;

"WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro, recognizes the urgency and importance of the said project and fully supports the initiative to safeguard the community and promote sustainable local development;

"WHEREAS, , the implementation of this project requires substantial funding and technical assistance, which are within the mandate and expertise of the Department of Public Works and Highways (DPWH); Now, therefore, be it..

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Department of Public Works and Highways (DPWH) to allocate funds for the construction of a gabion or dike along the river in Sitio Caguray, Barangay Benli, Municipality of Bulalacao, Oriental Mindoro,
