"WHEREAS, the Office of Civil Defense (OCD) is the national government agency primarily responsible for ensuring public safety and strengthening disaster risk reduction and management through preparedness, mitigation, response, and rehabilitation programs;

"WHEREAS, Sitio Caguray, Barangay Benli, Municipality of Bulalacao, Oriental Mindoro is situated along a river that is highly susceptible to flooding and riverbank erosion, especially during periods of heavy rains and typhoons;

"WHEREAS, the continuous erosion of the riverbank poses a serious threat to the lives, properties, and livelihoods of the residents of Sitio Caguray, particularly the Hanunuo Mangyan families residing in the area;

"WHEREAS, a significant portion of the land affected by the erosion constitutes ancestral land traditionally owned and occupied by the Hanunuo Mangyan, and the ongoing loss of land threatens their cultural heritage, primary source of livelihood, and way of life;
