RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 3

FURTHER AMENDING RESOLUTION NO. 37, ORDINANCE NO. 9, SERIES OF 1979, REDESIGNATING THE OPEN AREA, WEST OF THE PUBLIC MARKET, CAMPASAN, BULALACAO, ORIENTAL MINDORO AS PARKING SPACE FOR ALL BUSES, JEEPNEYS CARRYING PASSENGERS.

SECTION 1.- The open area west of the Public Market is hereby designated Parking Space for all Buses and Jeeps carrying passengers.

SECTION 2.- Sign boards shall be installed at A. Salas Street, such as: no Parking, Loading and Unloading only placed in the restricted areas.

SECTION 3.- F. Atienza Street is hereby designated One Way for all Vehicles entering Poblacion of this Municipality.

SECTION 4.- Parking Fee for Buses and Jeeps shall not exceed the rate enumerated below.

- 1. Buses ₱2.00 Per parking
- 2. Jeeps 1.00 " "

SECTION 5.- Collection of the above fees shall be done by the Municipal Treasurer or his duly authorized representatives hereof.

SECTION 6.- Violation of this Ordinance or parts thereof shall be fined the amount of ₱50.00 to ₱200.00 and an imprisonment of 10 days to 30 days or both such fine and imprisonment at the discretion of the Court.

SECTION 7.- Ordinances or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


SECTION 8.- This Ordinance shall take effect immediately upon its approval.
