RESOLUTION REQUESTING CONGRESSMAN ALFONSO V. UMALI, JR., 2ND DISTRICT REPRESENTATIVE, PROVINCE OF ORIENTAL MINDORO TO FACILITATE THE ALLOCATION OF FUNDS FOR THE RIPRAPING OF LANDSLIDE AREA IN REGIONAL EVACUATION CENTER LOCATED AT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Bulalacao is a first-class Municipality located at the southernmost tip of Oriental Mindoro with a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, Bulalacao, like many coastal and low-lying areas, is highly vulnerable to natural disasters such as typhoons and flash floods, it has a Regional Evacuation Center which is an essential facility for disaster preparedness, provides temporary shelter and safety for residents during calamities;

"WHEREAS, the land area adjacent to the regional evacuation center is susceptible to soil erosion and degradation, particularly during heavy rains and typhoons, which poses a serious risk to the structural integrity of the facility and the safety of its occupants;


"WHEREAS, the Local Government of Bulalacao recognizes the urgency of this project but requires financial assistance from a national agency due to limited local funds;
