"WHEREAS, the Provincial Government of Oriental Mindoro, under the
leadership of Honorable Governor Humerlito A. Dolor, has continuously
supported programs and initiatives that promote peace and order, gender
equality, and the protection of women and children throughout the Province of
Oriental Mindoro;

"WHEREAS, the Women and Children Protection Desk (WCPD) of the
Bulalacao Municipal Police Station plays a vital role in addressing and
preventing crimes involving women and children, ensuring their safety, and
upholding their rights in accordance with Republic Act No. 9262 (Anti-
Violence Against Women and Their Children Act of 2004), Republic Act No.
7610 (Special Protection of Children Against Abuse, Exploitation and
Discrimination Act), and other related laws;

"WHEREAS, the WCPD personnel are tasked with responding promptly to incidents and complaints involving women and children, conducting home and community visitations, and coordinating with other concerned agencies for case management and victim support;

"WHEREAS, the efficient and timely performance of these duties is often hampered by the lack of a dedicated service vehicle, which limits the mobility of WCPD personnel, especially in far-flung barangays of the Municipality of Bulalacao, Oriental Mindoro;

"WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro together with the Philippine National Police (PNP), recognizes the urgent need for a service vehicle that will significantly enhance the delivery of protection and assistance services to vulnerable sectors; Now, therefore, be it...
