NOW, THEREFORE, on motion of Hon. Ulpiano C. Pandino, seconded by  
Hon. Perpetuo C. Cantos,

RESOLVED, as it is hereby resolved to enact the following Ordinance,  
to wit:

ORDINANCE NO. 7 ✓

AMENDING RESOLUTION NO. 19, ORDINANCE NO. 6, SERIES OF 1983 AND DECLARING  
THE DAY OF SUNDAY OF EVERY MONTH AS THE MARKET DAY OF THE TOWN OF BULALACAO,  
ORIENTAL MINDORO AND SHALL PROVIDE FINES AND PUNISHMENT FOR VIOLATION HEREOF

SECTION 1. All persons, vendors and businessmen who are residing in  
this and adjacent municipalities are hereby enjoined to observe strictly  
the day of Sunday of every month as the market day of Poblacion, Bulalacao,  
Oriental Mindoro;

SECTION 2. The open area west of the Public market is hereby designated,  
the site of market day for all vendors and businessmen who are residing in  
this adjacent municipalities coming to display goods for trade;

SECTION 3. No person and businessmen are allowed to display and sell  
goods outside the area designated hereof, with the exception of those store-  
owners and businessmen in the Public market and those who had already perma-  
nently established their stores in their residential houses or lots;

SECTION 4. Violation of this Ordinance or parts hereof shall be fined the  
amount of ₱100.00 to ₱500.00 or imprisonment of 15 to 30 days or both such fine  
and imprisonment at the discretion of the court;

SECTION 5. Previous Ordinance or Ordinances inconsistent with the pro-  
vision of this Ordinance are hereby repealed or modified accordingly;

SECTION 6. This Ordinance shall take effect 10 days after its passage;


