WHEREAS, from the time of his assignment as classroom teacher,
Mr. Restituto J. Cezar, has made significant accomplishments in this
school deserving due recognition and appreciation not only by the Sang-
guniang Bayan but also the people of Bulalacao as a whole;

WHEREAS, because of his sincerity, devotion to duty and dynamic
leadership, Mr. Cezar has made several accomplishments enumerated as
follows, to wit:
